# THE BOROUGH OF OADBY AND WIGSTON (OFF-STREET PARKING PLACES) (VARIATION) (NO.1) ORDER 2022

Oadby and Wigston Borough Council (hereinafter referred to as "the Council") in exercise of its powers under Sections 32, 33, 35, 35a and 38 of the Road Traffic Regulation Act 1984 and Parts I, III, IV, V and VI of Schedule 9 to the Act, the Traffic Management Act 2004 ("the 2004 Act"), all regulations and Orders conferred by the 2004 Act and of all other enabling powers, with the consent of Leicestershire County Council in accordance with Section 39(3) of the Act and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 of the 1984 Act and the Area Traffic Commissioner under Part V of Schedule 9 of the 1994, hereby makes the following Order.

#### PART 1 – GENERAL

#### Title, Citation and Date of Operation

- 1. This Order shall come into operation on [ ] 2022 and may be cited as "The Borough of Oadby and Wigston (Off-Street Parking Places) (Variation) (No.1) Order 2022".
- 2. Any references to "this Variation Order" accordingly relate to "The Borough of Oadby and Wigston (Off-Street Parking Places) (Variation) (No.1) Order 2022".

### Interpretation

- 3. In this Variation Order, except where the context otherwise requires, the following expressions have the meanings respectively assigned to them:
  - "the Principal Order" means The Borough of Oadby and Wigston (Off-Street Parking Places) Order 2021.
- 4. Any reference in this Variation Order to a numbered Article is a reference to the Article bearing that number in this Order and any reference in this Variation Order to a numbered Schedule is a reference to the Schedule bearing that number in this Variation Order.
- 5. Any reference in this Variation Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
- 6. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

#### PART 2 – AMENDMENT OF THE PRINCIPAL ORDER

7. To replace any and all of the references contained in the Principal Order and all its Schedules as stated in column A with that stated in column B accordingly.

'Where available designated marked bays are for charging of electric and hybrid vehicles only.'


